**REMINDER: CONSULTATION ON THE PROGRAMME FOR GOVERNMENT DRAFT OUTCOMES FRAMEWORK**

We are writing to invite you to take part in a formal consultation on the new draft Outcomes Framework for the Programme for Government (PfG), which is set to close on **22 March 2021**. We are also running an Equality Impact Assessment (EQIA) Consultation until **30 April 2021**. We are keen to hear your views.

**Draft Programme for Government Outcomes Framework**

The Programme for Government focuses on achieving wellbeing for all. The new draft Framework sets out nine ambitious Outcomes aimed at making a real and positive difference to people's lives.

To ensure that the PfG is informed by citizen and stakeholder engagement and co-design, we would like your views on the high level draft Outcomes Framework – that is, the Outcomes themselves and the key priority areas that underpin them.

The consultation document contains the new draft Outcomes Framework and sets out the wider context to the PfG. It explains how it will provide the starting point for long-term strategic policy planning by the Executive as well as delivery of key strategies and actions moving forward.
